Respected Sir,

Through this complaint I would like to draw your kind attention towards the plight of the villagers of Sangarbari, Khalisamari Gram Panchayat, Block-Sitalkuchi, Sub-division- Mathabhanga, Cooch Behar district. The bordering populace, residing in the above mentioned village belong to a lower economic background, depending upon daily wage and agriculture. Most of the villagers have their land beyond the fences, making it difficult for them to cultivate on those lands due to illegitimate restriction imposed by the Border Security Force personnel posted there.

This particular complaint is with respect to the lack of employment opportunities of 100 day work available to them under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA). The villagers have been given job cards but none of them have received any jobs despite of this. It is the State's negligence towards the villagers of Sangarbari. It is shameful that after more than seventy years of our independence, the dwellers of this bordering village continue to live in condition of poverty, uncertainty and lack of social security schemes.

The villagers of Sangarbari submitted a written applications to the Pradhan of Khalisamari Gram Panchayat and Block Developent officer of Sitalkuchi Block to raise this concern but nobody took any step to rectify this continuous state of plight from such a long time, depriving the villagers of their basic right to work. On 26.05.20 Atul Basak s/o Ananta Basak had also submitted a written application to the Panchayat Pradhan of Khalismari Gram Panchayat, requesting to reissue his job card which was deleted, as informed to him by the Gram Panchayat office. This written application was received by the Panchayat office; however, no positive action has taken place in that respect yet.

Due to the lack of employment opportunities, the people of Sangarbari village might involve in migrating to other cities in search of jobs since they are solely depended on daily wage or trivial mode of incomes. This apathetic attitude violates directives laid down in writ petition (Civil No.196 OF 2001) People's Union for Civil Liberties vs. Union of India & amp; Ors and also violates the goal number 8 and 16 of Sustainable Development Goals as well. The present situation is a clear violation of Article 14 and Article 21 of the Constitution of India. The villagers are being stripped of their fundamental right to work and hence it must be immediately looked into and proper restitution must be provided.






