### Respected Sir,

This is to bring your kind attention to the situation of the villagers of Char Shibnagar under Malibari I Gram Panchayat and under Raninagar II Block in the district of Murshidabad. These villagers are belonging to Muslim minority community. The chief occupation of the villagers is farming and daily wage labour. Average monthly income of these villagers is not more than Rs. 3000/-. They are under extreme poverty.

During the time of critical situation of nationwide lockdown due to the spread of the Covid 19 virus, these villagers lost their daily wage earning and they were restricted to go to agricultural land for farming and therefore they were suffering from extreme financial crisis to let their life run.

In the meantime the natural calamity called 'Amphan' showed its devastating attitude and crashed the village areas in the State of West Bengal. This village is no exception. Small mud houses of these villagers made of tin shade or tali are completely destroyed in this great natural calamity. Their loss is huge. They have no work and even they have no financial capacity to repair their own house. Therefore, they requested to local Malibari I Gram Panchayat; Block Development Officer of Raninagar II Block; Sub Divisional Officer of Domkol and even to the District Magistrate of Murshidabad district to help them by repair their house or provide financial compensation; but no one hear their crying voice and till date they are living in their house which are destroyed completely and suffering from hot sunrays and rain in this monsoon season. Several victims send their complaint through the medium of Whatsapp to the Block Development Officer, Raninagar II Block (Whatsapp number 9434770036); Sub Divisional Officer, Domkol (Whatsapp number 9434770009) and District Magistrate, Murshidabad (Whatsapp number 9434770000) but till date no response was received by the victims in this regard.

Following I have mentioned the list of the villagers whose house are completely destroyed with the great storm 'Amphan' and who have not received any assistance from the district administration of Murshidabad.

They all are living at village Char Shibnagar under Malibari I Gram Panchayat and under Raninagar II Block in the district of Murshidabad.

More so, these villagers of Char Shibnagar under tremendous penniless condition do not run their life in this critical situation of nationwide lockdown due to spread of pandemic Covid 19 virus. Government issued standard operating procedure for implementation of MGNREGA during this bad situation throughout the country where it is mentioned that keeping in view of the distressed situation among the rural poor and labourers erstwhile migrated to cities and have returned to their own villages and in order to provide handholding support in terms of livelihood security to these people as well as the targeted vulnerable sections such as landless and manual casual labour or deprived section as per the SECC 2011 & household of SC families, ST families, PMAY-G beneficiaries, SHG's members, Women headed families and differentlyable headed families, Mahatma Gandhi NREGA can be the best available options to provide wage employment and thereby creating sustainable individual and community assets for enhancing livelihood security directly linked to livelihood i.e., Agriculture, Horticulture, Sericulture, Fishery and livestock. Instead of this standard operating procedure, these villagers did not get any chance to work under MGNREGA project during this critical stage. They several time verbally requested to the Pradhan of Malibari I Gram Panchayat but he was paid no attention to them.

The present situation is violating Article 21 of the Constitution of India. Are the provisions of Fundamental Rights dead during Corona war? Life is life, all lives are as godly but the

concerned authorities think otherwise. Is this our spirit of humanity? Why these poor people are being victimized of this situation or our governments become anti-poor?

I therefore, urge to your good authority to make urgent intervention into the matter by directing the concerned authorities to take active steps and provide financial compensation to the abovementioned villagers of Char Shibnagar whose houses were completely destroyed due to Amphan, a great natural calamity and also provide them with minimum employment guaranteed under the MGNREGA scheme.


