Respected Sir,

I am writing this complaint regarding detention of Bangladeshi persons in West Bengal and accusing and treating them as criminals under Foreigners Act, 1946. Since long MASUM is trying to bring the on-going malpractice into light by making numerous complaints to the NHRC and other relevant departments. The authorities including police and Border Security Force are not at all concerned to enquire into whether the persons including women and children crossed the border from Bangladesh to India were the victims of human trafficking or not. Here I am appending two case details for your perusal.

**Case 1:** In connection with Swarupnagar Police Station **Case no. 394/20** dated 17.08.2020 under section 14/14C of Foreigners Act, a Bangladeshi national, Ms. Laiju Sheikh, daughter of Chand Miya Sheikh, age-24 years, residential address: - village-Hijaldi, Police station - Kalarua, District-Gayabanda, Bangladesh was arrested. Swarupnagar police also arrested Mr. Tariqul Gazi and alleged that he was a tout who was helping Ms. Laiju cross the international border illegally. However, it has been revealed from our fact finding that Mr. Tariqul Gazi was working in his field, when he was called to visit the BSF Border Outpost by one R.C. Yadav, who told Tariqul that BSF has apprehended a lady but is not accustomed with her language. Therefore, Tariqul was called in the BOP to interpret her statement. However, when he reached the BOP to help the BSF, he was arrested with the allegation of being a tout. In the same FIR copy, the BSF has mentioned the names of another seven persons from different villages of the area who are not related to this case in anyway.

The victims were arrested at 9:15 pm on 17.08.20 and produced in the Basirhat ACJM court on 18.08.20, where their bail was rejected. They were again called for hearing on 19.08.20 but denied bail and are sent to the Dum Dum Correctional Home.

**Case 2:** In connection with Basirhat Police Station **Case no. 959/20** dated 18.08.2020 under section 14 of Foreigners Act the following Bangladeshi women and children were arrested:-

1) Ms. Janu Begum, wife of Mohammad Hossain, age - 35 years of Vill- Nandanpur, PS- Jagannathpur, Dist- Sunamganj, Bangladesh along with her 3 lap babies:

- i. Nur Kaios (6 years)
- ii. Nur Kalima (5 years), and
- iii. Mohammad Arman (4 years)

2) Modina Begum, wife of Imam Hossain, age - 50 years of Vill - Nandanpur, PS- Jagannathpur, Dist- Sunamganj, Bangladesh

Basirhat Police produced all of them before the Court of Additional Chief Judicial Magistrate, Basirhat, North 24 Parganas district. The court sent them to Dum Dum Central Correctional Home, for 14-day jail custody.

Our fact finding reveals that the arrested Bangladeshi persons entered India for the purpose of working in India as they are terribly poverty-stricken people with no jobs in Bangladesh. Most of them work as domestic help,

construction worker and hotel workers in various locations of India. The victims are either trying to enter India through the border or return to their home in Bangladesh with the help of local touts, involved in cross border illegal movements (both side of the border), when they are being arrested by the Border Security Force (BSF) personnel. These touts / middlemen / *DHURS* are operating in connivance with border guards of both sides, India and Bangladesh. The Bangladeshi persons arrested were treated as accused under the Foreigners Act and no attempt has been taken up by the police or the concerned court to ascertain whether they were the victims of human trafficking or not. Such approach of the criminal justice system is against the advisory issued by the Government of India vide office memorandum No. 14051/14/2011-F.VI of Ministry of Home Affairs (Foreigners Division) Government of India Dated 1st May, 2012 clearly states as *“(IV) it is seen that in general, the foreign victims of human trafficking are found without valid passport or visa. If, after investigation, the woman or child is found to be a victim, she should not be prosecuted under the Foreigners Act. If the investigation reveals that she did not come to India or did not indulge in crime out of her own free will, the State Government / UT Administration may not file a charge sheet against the victim. If the charge sheet has already been filed under the Foreigners Act and other relevant laws of the land, steps may be taken to withdraw the case from prosecution so far as the victim is concerned. Immediate action may be taken to furnish the details of such victims to the Ministry of External Affairs (Consular Division), Patiala House, New Delhi so as to ensure that the person concerned is repatriated to the country of her origin through diplomatic channels” and (v) During the interim period, pending repatriation, the victim may be taken care of in an appropriate children’s home, or “Ujjawala” home or appropriate shelter home either of the State Government concerned or of any NGO aided by the Government of India / State Government.’*

I hereby want to recall the Memorandum of Understanding signed by India and Bangladesh on bilateral cooperation to prevent human trafficking in women and children; signed by both countries on 30 May 2015.

I also want to mention that State agencies should pay respect to Constitution of India, in Article 51(c).

The present complaint reflects that the law enforcing agency by arresting the above stated persons and implicating them under the Foreigners Act as accused persons acted mechanically without giving any importance to legitimate entitlements of those arrested persons.

The incidents are not only violating the advisory of Government of India but in violation of Goal Number 16 of Sustainable Development Goals of UN, Government of India is a party to set the goals and obliged to adhere the same.

Under the circumstances I would request your authority to intervene in this present complaint and consider the following demands of justice for the victims:-

- The whole matter must be investigated by one neutral investigating authority.
- The concerned authority must be directed to hold an inquiry in compliance with the advisory issued by the Government of India vide office memorandum No. 14051/14/2011-F.VI of Ministry of Home Affairs (Foreigners Division) Government of India Dated 1st May, 2012 and pending the inquiry the victim women and children must not be treated as accused. .
- The victim persons including children should be immediately repatriated to their own country and prosecution launched against them should be withdrawn at the earliest.
- The local villager illegally arrested by the BSF should be released and disciplinary action should be taken against the guilty BSF officials for implicating him in fabricated case
- The constant flouting of advisory of Ministry of Home Affairs (Foreigners Division) Government of India by various components of criminal justice administration should be dealt with concern and offenders must be punished accordingly
