Proceeding	<p>The matter relates to the death of one cattle smuggler Jaynal Mia son of Abdulla in BSF firing on 16.08.15 on Indo-Bangladesh border.</p> <p>While considering the matter on 07.11.2019, the Commission had issued a notice u/s 18 of the Protection of Human Rights Act, 1993 to the Secretary, Ministry of Home Affairs, Govt. of India, New Delhi requiring to show cause within six weeks as to why a sum of Rs.Three Lakhs as monetary relief be not recommended to be paid to the next of the kin of the deceased Jainal Mai</p> <p>Accordingly, a show cause notice dated 21.11.2019 was issued to the Secretary, Ministry of Home Affairs, Govt. of India, New Delhi but no response has been received till date.</p> <p>In the circumstances, recommendation is made to Govt. of India through Secretary, Home Affairs to pay compensation of Rs. Three Lacs to the next of the kin of the deceased. With this direction the case is closed.</p>
