Proceeding	<p>The complainant alleges that victim, namely, Mrs. Bhagyabati Shil aged 19 years, belonging to SC Community was admitted to Sadikhanrdiar Rural Hospital on 23.11.2012. Due to gross negligence by the doctors and hospital staff, the victim mother got 25 stitches on her ravaged uterus and the new born child died.</p> <p>The Commission vide proceedings dated 13.12.2018 has asked the Govt. of West Bengal to pay an amount of Rs. two lakhs to the victim Bhagyabati Shil w/o Paritosh Shil as compensation.</p> <p>In response, the Additional Secretary, Home & Hill Affairs Department, Kolkata vide communication dated 19.03.2019 has submitted proof of payment received from District Magistrate, Murshidabad vide Memo No. 330/JM/En dated 12.03.2019 . A copy of the muster roll for payment of interim compensation to the victim Bhagyabati Shil, w/o Paritosh Shil vide cheque No. 329113 dated 07.02.2019 has also been enclosed herewith.</p> <p>Therefore, the case file is closed.</p>
